Brigadier General Mike Hayes speaks to Chamber About BRAC move of Walter Reed

On December 5th, Brigadier General Mike Hayes, USMC (Ret.), Director, Office of Military and Federal Affairs, Maryland Department of Business and Economic Development, addressed a joint committee meeting of the B-CC Chamber's Economic Development & Government Relations, Real Estate, and Parking & Transportation Committees to provide an overview of the BRAC move

of Walter Reed to Bethesda Navy Medical. The final execution of BRAC directed movement is required to be completed by the end of 2011. Hayes did say that because of the war in Iraq the completed date and the money that will be allocated to fund the project will probably not be decided until this time next year.

Once the merge is completed "the goal is to have 300 additional hospital beds at the facility and an additional 3,000 employees staffed at the Center," according to Hayes.

The facility will be renamed the *Walter Reed Medical Center*. He also noted in the meeting that the changes could mean an additional \$500 million dollars in personal property and income tax revenue for the state of Maryland.

Planning for local roads and infrastructure, especially regarding Wisconsin Avenue traffic and entrances to the facility, is currently underway and is being evaluated closely.

By January BRAC plans to have a website up and running that will contain information for business owners on partner with other businesses and how to interact with the Federal and local governments during this transition. The website (<u>www.</u> <u>choosemaryland.org</u>) will also instruct business on how to register and bid on projects that will result from the move. Look for more information regarding the BRAC move of Walter Reed to Navy Medical in future issues of ChamberNews.

Anti-spam Tips

What is Spam

In simplistic terms Spam, also known as Unsolicited Bulk E-mail (UBE), are e-mail messages that are unsolicited by the recipients. Often these unsolicited messages are sent to thousands of people at a time. Spammers most often are motivated by commercial gain and the cost to spammers to send thousands of messages is next to nothing. Spammers will often attempt to hide the true source of the messages and will also often use the computers of Internet users without their knowledge to send their spam e-mails.

Never purchase anything from an unsolicited e-mail message

Aside from encouraging spammers to continue their practices, by purchasing spamvertised products your contact and billing information may be exposed to individuals that often times do not have any interest in protecting your privacy.

Be careful when filling out web forms

When you sign for anything on the web often times there will be a checkbox stating that is okay for your information to be sent to "third parties" Also, often times, this checkbox is already selected for you – so make sure that you pay close attention to the form before you click submit.

Use a disposable e-mail address

There are several sites that offer the creation of temporary email addresses. This temporary e-mail address can be used to fill out web forms without exposing your true email address. For an example check out http://www.trashmail.net

Use the "remove me" link carefully

Unless you are dealing with a legitimate newsletter, never click the "remove me" or the "unsubscribe" link. This will almost certainly just verify to the spammer that he/she has reached a legitimate email address.

Use your Internet Service Provider's anti-spam tools

Most every ISP provides some level of anti-spam protection at no additional charge. Take the time to check your ISP's website on how to enable their anti-spam protection tools.


