### Bytes of Bethesda

#### Vanity, thy name is search (not woman)!

Vanity searches (entering your name into a Google or other search boxes to see how many places you show up on the Web) may create problems for you! Do you want strangers to know where you surf, your online reading habits or medical inquiries, political affiliation or even sexual orientation?

Search engines collect and store records of your search queries. To protect yourself, consider these "don'ts" (and for details, search for "vanity search - what not to do" and options):

- 1. Don't search for personally identifying information -- as tempting as it may be -- name, address, credit card number, social security number, or other personal information. These kinds of searches create roadmaps that lead to your doorstep, exposing you to identity theft and other privacy invasions.
- 2. Don't leave cookies on indefinitely. Some search engines add cookies that identify you while searching. Set your cookies to expire after each search, quit your browser and log out properly. Check regularly for updates to privacyprotection tools built into your applications.
- 3. Don't rely on plugins, such as Firefox's TrackMeNot, without doing a bit of research. Some of these may make it easier to link your searches together (ex., you are using a distinctive plugin). Some of these programs do not hide personally identifying information or your search inquiries.

- 4. Don't use unusual browsers, operating systems, language settings, or the like as you will stand out from the crowd, making identification easier.
- 5. Don't use your ISP's search engine. Your ISP knows you, can link your identity to your searches and individual queries into a search history. Comcast subscribers should avoid using http://search.comcast.net and AOL members, do not use http://search.aol.com -- and so on.

### Ask the Techie

O. "Does Size Matter?"

A. Yes, for online shoppers of items such laptops or monitors, especially where sizes are often only available in inches or centimeters. Dimensions just don't present a feel for the actual size such as you'd get when shopping in a brick and mortar store. The solution? A new web site, sizeasy.com, allows you to enter dimensions and see them drawn to scale next to everyday items (you choose from a deck of cards, a matchbox, a 32" TV and more).

### Legislative Action Update

Since the beginning of the year, The Greater Bethesda-Chevy Chase Chamber of Commerce has been involved at all levels of government in a variety of important issues.

**SUBDIVISION MORATORIUM** – In testimony before the Montgomery County Planning Board and the County Council, the Chamber strongly opposed a proposal to temporarily suspend approval of subdivision plans. This would have done irreparable harm to the county's economic development efforts. We are pleased that the Council unanimously agreed to reject this proposal.

**TRANSPORTATION PRIORITIES** – Testifying before the County Council, the Montgomery County Delegation to Annapolis, and the Planning Board, the Chamber reaffirmed our long-standing support for the Georgetown Branch Light Rail Purple Line project consistent with previously approved land use master plans. We also expressed support for efforts to secure funding for Maryland's Transportation Trust Fund, for long- range regional funding for METRO, and for transit ridership incentives.

COUNTY OPERATING BUDGET – In recommendations to the County Executive and in testimony before the County Council, the Chamber presented our thoughts and comments on the proposed 2007-08 County Budget. We emphasized transportation and transit issues, street maintenance and lighting, public safety and small business enhancement programs. We also voiced our support for the programs, operations and funding needs of our numerous partnership organizations responsible for delivering services and promoting safety, quality of life and economic well-being in the Greater Bethesda-Chevy Chase area. We are pleased to report that the budget submitted by the Executive and approved by the Council addressed most of our major issues and concerns.

#### PURPLE LINE LIGHT RAIL

- Continuing our long-standing membership in the Coalition to Build the Purple Line, our Chamber participated in the planning and conduct of a rally in Annapolis to demonstrate support for this much-needed project. Various Washington area legislators joined in the rally, which received state-wide media coverage.



BRAC IMPACT – The Chamber submitted comments to federal officials on the impact of the scheduled relocation of major functions of the Walter Reed Army Hospital to the National Naval Medical Center. We noted the positive opportunities this presents such as added incentive for construction of the Purple Line Light Rail and the south entrance the Bethesda Metro Station. We also made a number of suggestions for enhanced pedestrian and vehicular safety and access.

ANNAPOLIS DEVELOPMENTS – With a new governor and many new members of the General Assembly needing time to become acclimated to the workings of state government, several major measures advocated by the business community failed to be enacted this year. Among issues that will be reconsidered at the next session are health insurance incentive programs for small businesses, transportation funding, and general revenue and fiscal issues.

Anticipating critical revenue and tax discussions, the Chamber developed a position statement that will serve as the basis of our evaluation of proposals and suggestions to elected officials. A complete copy of this statement appears on p. 15 in this newsletter.

### **B-CC Chamber's Spring Walk-Around**

The old-fashioned, membership walk-around is back! On May 22nd, members of the Chamber visited businesses in the Bethesda, Chevy Chase and North Bethesda area, in an effort to promote the Chamber and recruit new members. 30 Chamber members volunteered to participate in this membership drive. which included Chamber information and cookies baked by The Bean Bag.

# Position Statement by The Greater Bethesda-Chevy Chase Chamber of Commerce Regarding Revenue and Taxes in MD - April 2007

The Greater Bethesda-Chevy Chase Chamber of Commerce recognizes the need to address a number of important revenue and tax issues confronting the State of Maryland. Among these is a significant shortfall in funding available to meet pressing transportation needs. A solution must also be found to correct a growing structural deficit in the overall state budget.

From time to time, various revenue generating measures have been under discussion. These include increases in the state gasoline and vehicle excise taxes, increase and expanded coverage of the state sales tax, dedication of a portion of the sales tax to specific needs such as transit and education, expansion of the corporate income tax, and others.

Before any revenue increase is enacted, the State of Maryland must demonstrate to taxpayers that the following considerations have been met.

- Accountability and fiscal responsibility must be the number one priority. Spending must be brought under control and reduced. Unnecessary, duplicative programs must be eliminated and consolidated. Efficiency and economy must be promoted throughout state government. Measurement standards must be implemented and the results periodically made public.
- The practice of enacting unfunded mandates must stop. Henceforth, any program requiring the expenditure of funds must be accompanied by a clear realistic revenue funding plan.
- Taxes should be fairly distributed throughout the community. No one segment, business or industry should

be expected to carry an unwarranted burden. It must be recognized that certain things such as good roads, transit and schools are a benefit to all. In one way or another, tax increases are ultimately borne by all citizens. This is most recognizable when it is direct such as a sales, gasoline or income tax. It is more subtle, but equally as onerous, when it indirect such as a business tax that is passed on to the consumer through a price increase or by a loss of jobs and a reduced tax base when a business fails or relocates outside the state because it cannot remain competitive under Maryland standards.

- Any tax on business, direct or indirect, should be carefully evaluated in terms of its effect on the ability to compete with businesses in surrounding jurisdictions and in other areas of the country.
- Distribution of state tax revenues to the local subdivisions should be accomplished on an equitable basis and should take into account the contribution of those jurisdictions to Maryland's overall tax base.
- Consideration of proposed new revenue measures should be done on a comprehensive basis, taking into account the cumulative effect of all taxes and Maryland's relative standing vis-à-vis competing jurisdictions throughout the country.

Based on the above criteria, The Greater Bethesda-Chevy Chase Chamber of Commerce will evaluate revenue and tax proposals and make our position clearly known to our elected officials. We are not opposed to reasonable measures, fairly applied, that meet these desired standards.
