# **Legislative** Update



#### **Waiting For Answers**

Too bad the lead-time for newsletter articles sometimes creates awkward situations. At the time this is written in early March, the Chamber and our members face more questions than answers.

With a month left in the General Assembly session in Annapolis, it is anyone's guess how the budget will be balanced and what, if any, tax increases will be put in place. One thing for sure, there will be program and funding cutbacks. These could well affect priorities important to the Greater Bethesda-Chevy Chase community. Transit funding is just one of the many areas that could feel the crunch.

The issue of slots at racetracks in Maryland also hangs in the balance. Despite the Governor's strong support for slots as a revenue source for the State, the General Assembly is split on this matter. The outcome is too close to call at this point.


Also pending is the Governor's decision for or against the Inner Purple Line transit project. He has until mid-March to decide whether this project goes forward for federal funding.


At the county level, by mid-March the County Executive will have submitted to the County Council his proposed operating budget for FY2004. Questions similar to those dealt with by the State will have to be addressed by the County. Where will be the cutbacks and what, if any, revenue enhancements will we see? By the end of May, we will know these answers.

Also by mid-March the results of last year's transit ridership survey in the Bethesda Central Business District are supposed to be released by the County. This is important because the results will determine whether Bethesda can move into its next stage of economic development. Indications are that the survey will confirm our Chamber's contention that we have attained the level of ridership that will allow us to proceed.

Answers to some of these questions will be known by the time of next month's newsletter. Others will fall into place later in the spring.
