

He pulled over to ask if anyone needed help and noticed that the young man being carried was semi conscious and choking. Walter called 911 for assistance and the CBD officers on his Nextel direct connect and then exited his truck and began to clear the young man's air way as he stabilized him on the ground.

While attending to the victim, Walter discovered from talking with the other students in Spanish that he was not having a seizure as they had first indicated, but was in fact having a bad reaction to "liquid E" (known as the "date rape drug"). The fire and rescue paramedics arrived quickly and transported the young man to Suburban Hospital where he did recover. Walter certainly made a difference once again in our community and in the life of this student!

When the Unthinkable Occurs in Your Business

Disaster Recovery Planning (DRP) is the process to ensure that an organization can continue to operate after a disaster that would normally preclude it from trading. A sound disaster recovery / business continuity plan is essential to protect the well being of an organization. This cannot really be over emphasized... yet many enterprises still side step the issue or hold plans which are clearly out of date or inadequate.

It is now generally recognized that business continuity planning and disaster recovery planning are vital activities. However, the creation (and maintenance) of a sound business continuity and disaster recovery plan, is a complex undertaking, involving a series of steps.

Prior to creation of the plan itself, it is essential to consider the potential impacts of disaster and to understand the **underlying risks**: these are the foundations upon which a sound business continuity plan or disaster recovery plan should be built. Following these activities, **the plan itself must be constructed** - no small task. This itself must then be maintained, tested and audited to ensure that it remains appropriate to the needs of the organization. And what about the support infrastructure and services?

The first step in a sensible business continuity process is to consider the **potential impacts of each type of disaster or event.** This is critical - how can you properly plan for a disaster if you have little idea of the likely impacts on your business/ organization of the different scenarios?

Having determined the impacts, it is now equally important to **consider the magnitude of the risks**, which could result in these impacts. Again, this is a critical activity - it will determine which scenarios are most likely to occur and which should attract most attention during the planning process.

These steps are only the beginning to a complete disaster recovery plan. Be sure that you have a complete, written recovery plan in place to insure the continuity of your business.



Legislative Update





Issues Update

Over the past month, decisions made in Rockville and Annapolis represent major progress on key issues important to the Bethesda-Chevy Chase business community.

In the area of transportation, the County Council, by a 7-2 vote, approved initial funding for the Montrose Parkway, linking I-270 and Rte. 355. This will cover the first phase of the project, which involves the design, right-of-way acquisition and construction of the project from Tower Oaks to Executive Boulevard. The final extension to 355 will be coordinated with State plans for improvement of the Montrose/355 interchange. Project design and construction is expected to continue over the next eight years.

In Annapolis, the General Assembly approved funding for completion of the study of the Inner Purple Line. This includes the Georgetown Branch Light Rail project, linking Bethesda and Silver Spring. Completion of the study will allow the State to compete for federal funding for this project in FY04.

Another major transportation victory at the State level was an overwhelming vote by both the Senate and the House urging the Governor to resume study of the Intercounty Connector. No action is expected from the current governor, who has blocked this project for the past four years. However, the future looks bright. All prospect candidates for governor in the coming elections have announced their support for the ICC. Moreover, at the federal level Senator Barbara Mikulski and Congressman Al Wynn have added their voices to other supporters of the ICC.

Locally, the County Council has endorsed the designation of Bethesda as an Arts and Entertainment District. If approved by the State, this would make available certain economic benefits and incentives to the designated area. Transit funding survived the General Assembly session without any major cuts. In Montgomery County, the County Executive has proposed full funding for Ride-On service. However, because of budget restraints, he has suggested the elimination of the "Fairshare" and "Super Fairshare" commuter incentive programs for FY03. These programs have been valuable marketing tools for promoting increased transit ridership in Bethesda. The Chamber and other groups and individuals have urged the Council to reconsider this decision and to include these programs in the approved FY03 Operating Budget.

Garage Update

The long-awaited Garage 36, located between Del Ray Avenue and Rugby Avenue in downtown Bethesda, will be open for business soon! The Parking and Transportation Committee has been monitoring the construction schedule and working with officials from the County to let them know our Chamber members' concerns regarding the extended delays for parking availability both in the new Garage and along Del Ray and Rugby Avenues. The 700 parking spaces in the Garage are expected to be available for public use in early May, although the meters may not be installed at the initial opening. Please be sure to visit Hard Times Café, located on Del Ray Avenue immediately across from the Garage, which has been very patient throughout this extended garage construction process.

The completion of Garage 36 will help employees and shoppers in downtown Bethesda with the upcoming restoration of Garage 11, located between Woodmont Avenue and Old Georgetown Road. When the restoration work starts in July 2003,

approximately 750 spaces in the old section of the Garage will be out of service due to necessary repairs to
