Letter From the Chair

As the Greater Bethesda-Chevy Chase Chamber begins its 80th year representing businesses like yours, it brings to mind the old saying "The more things change, the more they stay the same." What was America like eighty years ago? The Washington Evening Star headlines from 1926 looked like this:

- "The National Weather Bureau issued warnings of three large tropical storms building in the Caribbean. The warnings fell not on deaf, but uncomprehending ears."
- "Lighting strikes destroys an ammunition depot in New Jersey."

I can't help but compare these with Hurricane Katrina and the West Virginia mining disaster, the latter of which was caused by a lightening strike.

So natural events don't change, but people's behavior certainly does, right?

The B-CC Chamber's first President wrote a draft history during his term eighty years ago: "In May 1926, a plan was approved to create a Bethesda Fire Board and establish the Bethesda Fire Department, Inc." Each resident who contributed \$1000 during the previous summer's fundraiser could have a seat on the Board, as could each of the citizens associations. The Bank of Bethesda donated a parcel of land on Old Georgetown Road for a fire station later that year.

This small example, so local in scope, leads us to realize that people's inclination to organize and assist each other for the greater good doesn't change either.

Let's enjoy each other's company at the upcoming Golf Classic, and then let's celebrate the eighty years of advocacy, resources, community service, membership development and services provided by our Chamber at the Installation Dinner in June. I look forward to seeing you there.

Legislative Update

COUNTY BUDGET ISSUES

Each year our chamber testifies before the Montgomery County Council on items in the County Operating Budget that are of particular importance to the Greater Bethesda-Chevy Chase business community. When we testified last month on the FY 07 budget, a number of important new issues were addressed.

We made certain the Council understood that as residents, taxpayers, and business people, members of our chamber are interested in all aspects of the county budget. For emphasis, we stressed those matters that are our top priorities.

We assured the Council that we continue to enjoy close working relationships with our Greater Bethesda-Chevy partner organizations in the areas of public safety, education, economic development, transportation, and arts and humanities. We offered our total support for the programs, goals, operations and funding levels for these entities.

We commended the Council and the County Executive for agreeing to provide county funding for critical state

road projects for which state funding is not presently available. One of our key road projects, the intersection of Montrose Parkway and Route 355, would benefit from this decisive action. Also with respect to vehicular traffic, we urged the county to address as



soon as possible the deteriorating condition of the streets in the Bethesda area.

We expressed continued support for transit programs and rider incentives. In this regard, we urged that funds be provided for the completion of a planned south entrance to the Bethesda Metro Station.

Our testimony on the budget was well received by the Council. On their part, a number of council members thanked our chamber for the help we give them on various issues, particularly transit and transportation, and for the support we provide to organizations and entities in the Bethesda-Chevy Chase area.
