

With the upcoming holiday season, it is more important now than ever to give the gift of life at the Chamber's Bi-Annual Blood Drive. Each year more than 100 community business leaders take time out of their busy day to donate blood.

This year's drive will be held Tuesday, November 26, 2002 from 8:00 am to 2:00 pm at the Hyatt Regency Bethesda, which will be providing delicious cookies and will be hosting the event. This year, the law firm Lerch, Early and Brewer will be sponsoring the event and challenging all members of the chamber to join them in giving blood. Statistics show that 95% of the population will at one time in their lives have a direct need for blood or blood products; however, less than 5% of the population actually donates. To be a blood donor you must be at least 17 years old, weigh 110 pounds or more, and be in good general health. The process for donating usually takes approximately 45 minutes. Please come out and support your local community by donating your life-saving blood. With each donation three lives are saved.

Parking will be provided free of charge to all donors, and each person will receive a free goody bag!



## **Assistive Technology for People with Disabilities**

Many businesses are aware of the need to comply with the American Disabilities Act when it comes to their employees with disabilities, particularly physical impairments. But did you know that the National Institutes of Health estimates that approximately 15 percent of Americans are affected by learning disabilities? People who struggle with reading include those with low vision due to macular degeneration or blindness, people with dyslexia, attention deficit disorder (ADD) and other issues.

Fortunately, easy-to-use Assistive Technology is available to increase the reading speed and productivity of people with reading difficulties. For example, scanners were invented by a 19 year old student at MIT in 1969 for people who were blind, and Stevie Wonder purchased the first commercially available scanner ever made.

"Bytes of Bethesda" is a service of the Chamber's Technology Resources Committee, which invites members with an interest in current technology trends to join and participate in the committee, which meets the first Thursday of every month in the Chamber's Board Room. Members are also invited to write technology-related articles for the ChamberNews' "Bytes of Bethesda" column.

Text-to-Speech Software - uses powerful OCR (Optical Character Recognition) to scan text and read aloud the printed document. Printed materials can include books, magazines, photocopies, faxes, worksheets and almost any other typed material. The OCR in specialized reading software, such as the Kurzweil 1000 and Kurzweil 3000, can handle even complex documents with tables and charts and includes the ability to read several foreign languages, the Internet, provide definitions and even summarize a scanned document for you using artificial intelligence!

Screen Reading software - has the ability to magnify and read "electronic" text, including proofreading aloud word processing documents, spreadsheets and e-mail. A product such as textHELP will even read aloud the spellchecker and find homonyms (too v. to, their v. there) which normal spellchecking overlooks.

CCTV's (Closed Circuit Television's) - are specifically designed to enlarge print for people with low vision. Place any book, magazine, photograph or letter on the viewing table and the machine will magnify the print onto the screen up to 50x!

## **Legislative Update**

#### **Post Election Blues**

Six months of tumultuous Maryland politics are over. Beginning with a questionable redistricting plan ultimately redrawn by the courts, through hotly contested primary and general election races, the victors have prevailed and now await the moment when they take the oath of office for their hard-fought positions. Ordinarily this would be a time for celebration. But as any knowledgeable local or state elected official is well aware, celebrations this election cycle will be short lived.

Facing the Governor, the General Assembly, the County Council and the County Executive are fiscal problems of major proportions. Most of these originate at the state level and result from declining revenues and overspending. These difficulties will adversely impact the counties, and will ultimately affect all taxpayers and residents throughout the state.



Maryland faces an operating budget deficit of \$1.7 billion through next fiscal. If the economy remains stagnant, this deficit could grow worse. There is also a requirement for the state to fund \$1.3 billion in mandated education aid. In addition, the Transportation Trust Fund has a projected shortfall of \$29 billion over the next eighteen years, and this does not include projects such as the Intercounty Connector and the Purple Line. Cutbacks in spending, including reduction in aid to the counties, and tax increases will be the order of the day.

Beginning in January and continuing over the next several years, the General Assembly will be considering revenue-generating proposals such as increases in the sales, property and gasoline taxes, expansion of the sales tax base, and authorization for slot machines at certain locations in the state.

Certain to be affected by drastic reductions in state spending, Montgomery County is preparing to deal with its own cutbacks in spending, delays in capital projects, and increases in taxes and fees.

Although it will be up to our newly elected officials to develop and act on the details of these proposals, we can be sure that in one way or other we all will have to bear our fair share of the burden. That is no cause for celebration either for our elected officials or us.

## Master Business License Required of all Companies Doing Business in the District of Columbia

(with \$2000 or more in gross revenue)



Every business that does business in the District of Columbia with more than \$2,000 in gross receipts annually must obtain a Master Business License. If the main office of a business is maintained and operated outside of the jurisdiction of the District of Columbia, however this business executes contracts for work performed or services rendered within the boundaries of the District of Columbia, that business is required to obtain a Master Business License.

The DC Department of Consumer and Regulatory Affairs (DCRA) announced that the Master Business License (MBL) for businesses that meet certain criteria — businesses located in the District's commercial zones, or those that conduct business within the District but are located outside the city, need to apply for the District's new "Master Business License" before December 31, 2002,
